## What Is the FINTEPLA REMS (Risk Evaluation and Mitigation Strategy)?

A REMS is a strategy to manage known or potential risks associated with a drug and is required by the US Food and Drug Administration (FDA) to ensure that the benefits of the drug outweigh its risks. FINTEPLA is available only through a restricted distribution program called the FINTEPLA REMS because of the risk of valvular heart disease and pulmonary arterial hypertension.

## What Are the Requirements of the FINTEPLA REMS?

Prescriber requirements	Pharmacy requirements	Patient requirements
<ul style="list-style-type: none"> <li><b>Become certified</b></li> <li>As you start a patient on FINTEPLA, <b>counsel and enroll</b> the patient, evaluate baseline ECHO, and submit ECHO results to the REMS</li> <li>Perform ongoing <b>monitoring of the patient's CV status via ECHO</b> every 6 months and once 3 to 6 months after treatment discontinuation</li> <li><b>Document and submit</b> the ECHO results and authorization for treatment to the REMS</li> <li><b>Document and submit</b> ECHO results suggestive of PAH, VHD, or other CV abnormalities to the REMS</li> <li><b>Report</b> treatment discontinuation or transfer of care to the REMS</li> </ul>	<ul style="list-style-type: none"> <li><b>Designate</b> an authorized representative to certify in the REMS</li> <li><b>Train</b> staff</li> <li>Before dispensing, <b>obtain authorization to dispense</b> by contacting the REMS</li> <li>Inpatient pharmacies, <b>dispense</b> no more than 15 days' supply at discharge</li> <li><b>Recertify</b> in the REMS if the authorized representative changes</li> <li><b>Comply</b> with audits</li> </ul>	<ul style="list-style-type: none"> <li><b>Understand</b> the risks associated with FINTEPLA</li> <li><b>Enroll</b> in the REMS with your healthcare provider</li> <li><b>Get an ECHO to check your heart</b> <ul style="list-style-type: none"> <li>Before you start FINTEPLA</li> <li>Every 6 months to continue treatment</li> <li>Once 3 to 6 months after stopping treatment</li> </ul> </li> <li><b>Tell</b> your healthcare provider if any signs or symptoms of PAH or VHD develop</li> </ul>
